Dear-

According to our most recent records, your school district is one among approximately 65 districts in the state which still has an American Indian related mascot, logo or nickname. I am writing to strongly urge you to take steps to change this mascot to one which is ethnic (as well as gender) sensitive.

As you are probably aware, the Attorney General issued an opinion in 1992 that the use of American Indian mascots, logos and nicknames in public schools may be a violation of s.118.13, Stats. While this is a legitimate, legal reason to seriously undertake a review of your school's mascot or logo, other important reasons also exist.

Many American Indians, American Indian educators, American Indian educational organizations, the NEA, local and regional religious groups and a growing number of private citizens believe that Indian related mascots, logos and nicknames promote stereotypes and bias. They contend that these mascots are racist in nature in that they demean and distort the culture, religion, and historical and contemporary image of American Indian people.

At the Department of Public Instruction (DPI), we hear and recognize these concerns. While some would dismiss these voices, expressing that they are honoring Indians with their mascots, and that they see them as a source of pride, we at DPI have to ask the question, "How can you be honoring people while they are telling you that what you are doing is demeaning to them?"

As a general principle, there should not be any curricular or extra-curricular component of any Wisconsin public school which promotes stereotypes about any religious, ethnic, or other protected group. The department is compiling an ever growing list of individuals and organizations which state that American Indian mascots in public schools need to be changed to something that does not promote stereotypes and bias and is non-offensive to pupil and adult populations in Wisconsin.

In 1989, the legislature passed several laws which require school districts, starting in September 1991, to teach about Wisconsin tribal history, culture and sovereignty. This was due to the acknowledgement that both adult and pupil populations in Wisconsin were largely unaware and lacked understanding and sensitivity concerning treaty rights of Wisconsin tribes and bands. The question then needs to be asked, "How can we be promoting the understanding of tribal history, culture and sovereignty in the classroom while we are, at the same time, promoting Indian stereotypes on the football field, on the basketball court, in the school newspaper, on school stationery and in other areas?"

I believe American Indian related mascots, logos and nicknames are entirely inappropriate for use in Wisconsin's public schools. Again, I strongly encourage you to take steps to eliminate these in your school district if you have not already done so.
